### FINANCE REPORT: Balance \$1,545 cking \$5 in savings (14 memberships, \$150 donations)

1. Budget #3 Proposal (Geoff presented on behalf of Finance Task Group) met Feb 23 – Ron K had done pro forma with Geoff's numbers, and Geoff condensed into simplified budget. 6 month projection and evaluate w/actual numbers for budget into 2016, set up business partners - consignment vendors from area to help stock goods in exchange for ad signs in space, asking for donations for specific equipment/hardware – such as bins (POS system quote \$10,500, John P waiting on feedback from another source, keep evaluating), Need at least \$13,500 to open, NEED TO FOCUS ON PRODUCT specificity – not just anything (ck w/other co-ops and what sells regularly). Jason has list of Crow Wing food co-op sales, and Mary P has list of products from Azure buyers – stock products that result in most bang for buck (steer clear of short shelf life). LOCAL goods key for creating destination (bath and beauty, honey, maple syrup, preserves, wild rice, flour, meat). Rent options presented by Barb from Kidders (1 yr lease \$9,200/ 2 yr lease \$8000). Farm market (1st few markets free, \$10/time run mid may – Sept/Oct),

Other comments regarding product: get commitments from co-op members to purchase the local produce and put in "orders" so to speak (like CSA boxes) – coop could buy CSA share from Dan & Vanessa Bye, serve to coordinate with CSAs. Take orders for whole hogs, beef. On-line FarmStand.com. good idea to link in with vendors. Promotion local! Bulletin Board – promote local

growers/producers/businesses. Relationships. Be ready to take food stamps. Promote on web site what needs are "wish list" with prices for soliciting donations.

BUDGET: Need to add in something for POS system – based on \$2100 -20% down, \$223/month based on CoPOS quote \$3,215 for 6 months. We have \$6,000 in for manager, USDA program that provides interns – free for summer (reduce labor to \$2,500 – 14 hrs/wk \$12/hr) and add in \$3500 for POS.

Accept the budget proposed for May-October 2015 as of March 2, 2015, 7:25pm.

Goal \$3,000

Possible cookbook creation and sale – after some discussion decided though it's a good idea, would take more volunteer time and effort than currently available. Did suggest setting up recipe and local resource sharing on the website and John P is working on this.
