Farmers Market-Denise/MJ: We have 14 vendors committed, all but 2 returning from last year (1 passed away, other too busy at their own farm). Price STAYED at \$10 (same as last year), 20 markets (20 Saturdays from May 15 to September 25) total. Hired Farer's Market Manager-Barb Hammer, paid via stipend with the vendor fees making that payment possible. No money from coop is being used-we are trying to make the market support itself. NEW PROGRAM FOR KIDS: "PASSPORT PROGRAM". A grant was received to pay for this attempt to get kids and families to attend the farmers market (and hopefully shop in the store). Kids age 3-15 can sign up at the farmers market table and get 1 free carton of water per month to support the re-think your drink campaign (Crow Wing Energized grant), other items they will receive such as tattoos, stickers, word finds, color sheets, and possible garden tours can be added in the future.

OLD BUSINESS

Grant update-Denise: We received the Crow Wing Energized grant to pay for Passport Program materials and water. We did NOT get the "Round-Up" grant from Crow Wing Power.
